The Government of People's Republic of Bangladesh (GoB) is going to implement a road project named "Construction of 4-Lane connecting Road(with 2 lane service road on both sides) for payra 1320 MW Thermal Power Plant (From Rojopara at 12 km of Amtoli-Kuakata Regional Highway R-881 to Tiakhali Bridge)". A portion of fund is intended to be used for payments under the contract for Project Management Consultant (PMC) (Supervision Consultant) for which the EOI is issued.
- 2. The project comprises the following components:
 - a) Construction of 3.2 kM 4-Lane connecting Road (with 2 lane service road on both sides) for payra 1320 MW Thermal Power Plant (From Rojopara at 12 km of Amtoli-Kuakata Regional Highway-881 to Tiakhali Bridge).
 - b) 9 culverts and other necessary works.

The Roads and Highways Department (RHD) (Executing Agency) under Road Transport and Highways Division (RTHD), Ministry of Road Transport and Bridges (MRTB), (hereinafter referred to as 'the Client') now invites Expressions of Interest (EOI) in English from Bangladeshi Project Management Consultant or a Joint venture of Bangladeshi firm(s) (hereinafter referred to as 'the Interested Consultant') for short listing of firm/firms for the captioned services.
- 4. RHD will select and employ consultant for rendering consulting services of the project and cost of the aforementioned services will be made Government of Bangladesh funds.

 - b) Procurement Assistance
 - i) Procurement support as required for the project.

 - iii. In the list following information should be provided for the Contracts designed/supervised: Client's name, nature of services, contract amount, man-months, duration of the service with commencement and completion date;
 - e) Summary of permanent professional employees with key qualifications;
 - f) Number of Highway Engineers, those who belong to the firm more than one year and average working experiences more than 10 years of those Highway and Bridge engineers;
 - g) Audited financial statement (Balance sheet, Profit & Loss Account and Cash Flow Statement) for last 3 (three) years;
 - h) Average annual turnover in last 3 (three) years; and
 - i) History of litigation in courts or any arbitration proceedings (if any).
